## Entries and Run Details

**Dog Registration:** Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee. You may register your dog online at <http://nasda.dog/registration/>.



**Run Order:** Trials will be run concurrently. First dog on the line at 9:00am each day.

**Move Ups & Downs:** In accordance with NASDA rules, move ups and downs are permitted for teams who complete a title at the event. All changes must be made before the class in which the team wishes to compete begins.

**Awards & Fun:** Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying score, Best of Breed and High in Trial. New title rosettes will be awarded.

**Bitches In Season:** Bitches in season are eligible to compete. They must notify the Trial Secretary via email in advance of the trial. Bitches in season will run at the end of the event and must wear appropriate britches.

**Withdrawing Entries/Refunds:** No entry fees shall be refunded if a dog is absent. Also, no entries will be refunded if a dog is disqualified, excused, or banned from competition by the trial committee. Any entries pulled prior to pre-entry closing date must be made via email or mail and entry fees, less online service fee if applicable, will be refunded. Refunds won't be given if pulled post-closing date.

## Venue and Parking

Exhibitors will be crating in their vehicles. **Track N Texas** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Do not arrive prior to site opening.

## Notice to Exhibitors

- Online entries are available for this trial. You can go to [dogshow.com/events](http://dogshow.com/events) to register online.
- If you wish to mail in your entries, you can send payment along with the completed entry forms to the trial secretary. All checks will be made out to Tera Holder.
- For Level 3, there will only be one set up. Handlers with multiple dogs in the same class at this level please take note.
- Entries are limited to 7-hours of judging per day. If this trial fills, a wait list will be created as needed.
- Pre-entry deadline is: October 26<sup>th</sup> at 6pm CT. Entry fees for entries made after the deadline increase by \$5/trial
- Exhibitors are responsible for complete, accurate and legible information on their entry forms
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, weather, acts of God, public emergency, an act of a public enemy, or any cause beyond the control of Track N Texas.
- All dogs must be on leash at all times except when competing
- Exhibitors are responsible for being in the staging area when it is their turn to run. The judge need not wait for any dog holding up a class because the exhibitor is not ready. It is the exhibitor's responsibility to be ready for their runs. Track N Texas has no obligation or responsibility for calling or locating dogs that are not brought to the line when required.
- Please be courteous and pick up after your dog. Failure to clean up after your dog will result in immediate dismissal from the trial grounds and no refund will be given.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$50 fee for any returned check or payment. Checks must be made payable to Tera Holder.
- Track N Texas reserves the right to refuse any entry without cause or explanation
- Track N Texas reserves the right to remove any individual for any reason from the premises. No refunds will be issued
- Please pack food, shade and water for you and your dog.
