**Pre-entry fees** are \$15 for Instinct, \$25 for novice, \$30 for all other classes. Late/Day of Show entries will be \$20 for Instinct, \$30 for Novice, and \$35 for all other classes.

**Online entries will be accepted through [dogshow.com](http://dogshow.com)**

A service charge of 10% will be assessed for entries sent online or any entry using a credit card for payment.

Entries will be accepted until the closing date or until the limit is reached. Entries are limited to 260 MRV per judge per day. Late and Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

Judges are limited to 8 hours of judging and a maximum run value, which will require this Club to limit entries accordingly. Any Judge of Record at this Event may be used as a Load Balancing Judge in any ring. Dogs may enter Instinct and Novice.

Trial 1 each day – Instinct, Novice, Open, Senior, Masters  
Trial 2 each day - Novice, Open, Senior, Masters, Crazy 8's

## NOTICE TO EXHIBITORS

The building will open at 7:30 am and will close 1 hour after the trial ends. No dogs may be left in the building overnight. Check-in will be from 8:00 – 8:30 am each day. The judges briefing will be at 8:45 and the trial start time is 9:00 am.

- Bring chairs and crates. There is plenty of crating room inside.
- Possessing or training with personal, live quarry is not permitted on the show grounds at any time.
- All dogs must be on a leash at all times except when in the ring.
- Exhibitors are responsible for cleaning up after their dogs.
- Exhibitors are responsible for being ready to go to the blind, and waiting for the call to the gate when it is their turn. The judge need not wait for any dog.
- HPKC assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.
- This trial is open to all breeds and mixed breeds of all sizes – a BHA # is required. A Barn Hunt number may be obtained by going to [www.barnhunt.com](http://www.barnhunt.com)

**All Entries** must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$40.00 fee for all returned checks. Cash, check or PayPal are accepted. However, there will be a \$3.00 charge for each PayPal entry. Paypal address is [heartoftheplains@yahoo.com](mailto:heartoftheplains@yahoo.com)  
**We will be using dogshow.com to accept online entries via credit card.**

**Bitches In Season (BIS)** may compete at Barn Hunt trials. They will be run at the end of each class. BIS must wear pants/britches at all times when not being pottied, including on the course. Owners of BIS should crate/confine their dogs away from traffic and other dogs.

**Refunds:** Entry fees will not be refunded after the closing date or in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the Event Committee.

**The rings** are indoors and will be on dirt. This is a horse arena, used for training horses for many years. There are fans but no heaters or air conditioning so plan accordingly for yourself and your dogs.

**The Blind** will be inside, 10 x 20, on dirt with six competitors loaded per blind for Instinct, Novice, and Open; 5 for Senior/Crazy 8s; and 4 or 5 for Master.

**The Barn Hunt grounds** include the arena, the parking lot on the south side, and the grassy area surrounding the arena.

**Collars and Leashes:** Approved collars include flat snap or buckle collars of solid construction and leather or nylon leashes. Prong collars may be used while walking the dog and covered prong collars with a buckle may be used in the blind and on the way to the ring. Per BHA rules, electronic collars, including bark collars and citronella collars, as well as head halters are not allowed. Limited slip martingale and single piece slip leads and harnesses are allowed. Dogs may not be brought to the gate on a flexi lead. Dogs will run without a collar or leash but will enter and exit the ring on a collar or harness.

**Move ups**, including lateral, trial to trial and day to day are allowed but must be turned in to the trial secretary on a Move Up Form a minimum of 30 minutes before the class starts.

**Ribbons:** In addition to the standard ribbons for placements, there will be New Title ribbons, High In Class, RATCH, and RATCHX as well as other special awards.

### **Height Divisions:**

Small, Dogs 13" & under;  
Medium, Dogs 13.1" to 18",  
Large, Dogs over 18".

Dogs are measured at the option of the judge.
