ABOUT OUR JUDGES: Judges are limited to 8 hours of judging and a maximum run value, which will require the Club to limit entries accordingly. Load Balancing or assignment splitting may be done at this event. Any Judge of record at this event may be used in any ring. Qualifying scores will show the Judge who designed the course.

Entry fees:

Instinct \$15, Novice & Open \$20,

Crazy8s \$25 – note all Crazy 8's classes are limited to 20 dogs
Senior, Master, Championship, \$25

Day of Show and late entries will be accepted if limits allow. Add \$5 per run if entering Day of Show

Entries open on Mar 17th at 6pm, on a first received basis. We will continue to accept entries until limits are met or until April 14th. A maximum number of entries, up to 30% of the total allowed, will be reserved for Judges of Record, Trial Committee Members and members that commit to setup and tear down.

Electronic Entries and Payments: We are taking electronic entries and payments for this trial. If you use this method, you **MUST** go to www.dogshow.com, select barn hunt and find us there. We will be notified of your entries. There is a non-refundable convenience fee attached to online entries.

🐾 **MOVE UPS:** Move ups/downs/laterals are available trial to trial depending on class run order.

🐾 **BLINDS:** Are indoors, 10'x20' and dogs will be blinded in groups of no more than 6 for Instinct, Novice, Open, 5 for Senior, Crazy 8's and no more than 5 for Master.

GENERAL EXHIBITOR INFORMATION

🐾 **CRATING:** There is limited indoor crating available for this event. Dogs must be on lead at all times when not in the ring hunting.

🐾 **COLLARS & LEADS:** No electronic collars, bark collars, muzzles or head halters allowed on Barn Hunt show grounds. Per Barn Hunt Association all pinch collars must be covered.

🐾 **BITCHES IN SEASON (BIS):** May compete but must be run at the end of each class. BIS must wear pants at all times when not in their vehicle except when being pottied in the designated BIS potty area. Please inform the Trial Secretary prior to the start of the trial so your fellow exhibitors can be made aware of BIS present.

🐾 **HEIGHT DIVISIONS:** Small – Dogs 15.0" and under at the withers, Medium – Dogs 15.1" to 22.0" at withers, and Large – Dogs over 22" at the withers.

🐾 **DOG AGGRESSION:** A judge or the trial committee may dismiss any dog behaving in a threatening or aggressive manner toward another dog or person. Please report any issues immediately!

🐾 **ANIMAL SAFETY:** The safety of our dogs and rats are our primary concern. By entering these trials, exhibitors acknowledge they are familiar with the rules and regulations of this sport and that their dogs are familiar and physically able to perform all course elements.

🐾 **GROUND:** Barn Hunt grounds consist of all areas inside the building, the parking areas around the building, any grassy or concrete areas around the building

🐾 **AWARDS:** Qualifying ribbons for all qualifying scores. Placement ribbons by height for 1st through 4th place for all A classes and Championship. Placement ribbons for 1st through 4th regardless of height for B classes in Novice, Open, and Senior. High in Class rosettes for all A classes and Championship. New Title rosettes for a new title in any regular class. We also have Crazy 8 medals for those teams who earn their Bronze, Silver, Gold or Platinum awards. We have a special award for teams that earn their first Ratch with our club. Please let the secretary know if you think you may earn a Ratch. If awards are not claimed by Sunday afternoon, they are considered to be donated back to the club. We will not save them for you, nor will we ship unclaimed ribbons.

🐾 **REFUNDS & CANCELLATION POLICY:** After the closing date, entry fees will not be refunded in the event that a person or dog is absent, disqualified, excused or barred from competition by action of the trial committee.

Every attempt will be made to hold this event as scheduled. The club will refund all monies less what is needed to pay for unrecoverable costs if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee.

Abuse of any kind toward volunteers, dogs, rats, judges, competitors, grounds, or the trial committee will not be tolerated and will result in immediate dismissal from the event with no refund.

🐾 **WITHDRAWALS**

After the closing date due to injury of the dog will receive a 75% refund of paid entry fees. Request for refund must be accompanied by a dated note from a veterinarian and must be emailed or mailed to the Trial Secretary prior to the start of the trial Sunday morning.

If you do not follow all health/safety rules as outlined by BHA, Muttworke, or local and state governments, you will be asked to leave the grounds immediately, and there will be no refund of your entry fees.

🐾 **RETURNED CHECKS:** A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks.

🐾 ON SITE CAMPING: Dry camping may available at this event.
You must be self-contained as there are no hook ups available
Check with the secretary for more details. There are multiple RV parks within 10 miles.

🐾 OFF SITE ACCOMODATIONS: There are numerous dog-friendly hotels and campgrounds in the area. Please know the pet policies before booking.

🐾 DIRECTIONS: Off highway 67 with easy access and well marked. Look for the red bay doors. The venue is right next door to a portable building contractor. Small buildings line the front of the adjoining property.

🐾 SMOKING: Smoking is not allowed in the building.

🐾 FOOD: There are numerous coffee shops, fast food, diners & restaurants within 10 minutes of the venue.
