Incomplete and/or unsigned entries will delay processing and may be returned. PRE-ENTRIES must be RECEIVED by April 20, 2026. Maximum of 10 dog entries per envelope.

Move-ups/downs/lateral ("moves") prior to the trial will require the entry fee for the higher class to be paid and sent to the Trial Secretary before the trial. No additional fee for move-ups achieved during the event.

Move-ups/lateral moves will be allowed from trial to trial. You need to decide if you want to either stay in that class and move to "B" or move up to the next class in "A". Move ups/lateral moves will be allowed as permitted by the class order each day or between trials. Please see the Trial Secretary for the form and to assist with the process!

**Awards:**

Awards Placement rosettes will be awarded for 1st through 4th place in Novice, Open, Senior, and Master classes in each height division for the A Classes and for Master B with all heights combined for the B Classes other than Master. Qualifying ribbons will be awarded for all qualifiers in the classes, including instinct. New Title Rosettes will be awarded to those who qualify, excluding Instinct. High in Class rosettes will be awarded to fastest qualifying run in each class, excluding Instinct.

**Directions to the Event:**

From Atlanta: Highway 85S exit 21 to 185S. Take exit 42, Pine Mountain exit. Left at Stop Sign. Approximately 10 miles to Pine Mountain. Turn right on Harris Street, next to Circle K gas station. In approximately one mile out when you see the entrance to Callaway Gardens, veer to the right and at the next street on the right is Bethany Church Road. Turn in to first driveway and you will see a sign for parking.

From Columbus: Highway 185 North. Exit on Highway 18 exit, turn right at Stop Sign. Approximately five miles turn left on Bethany Church Road. Take an immediate left into the driveway and you will see signs for parking.

## General Information and Policies

It is the responsibility of each competitor to read and understand the current Barn Hunt Association, LLC (BHA) Rules prior to participating in this event. <http://www.barnhunt.com/forms/barnhuntrules.pdf>.

Please note: A BHA registration number is required for a Trial! You can register your dog on line at <http://www.barnhunt.com>. BHA registration fee is \$34 and is a lifetime fee for that dog. There are no annual fees with BHA, and no membership fees for dog owners.

Possessing or training with personal tubes and/or live rats is NOT permitted on the event grounds at any time.

Events will be held under cover, on grass. Dogs must be leashed or crated when not in the blind or ring. Crating is outside or out of your car. Please pick up after your dog and dispose of waste in appropriate containers. Multiple potty areas are available.

Barn Hunt Grounds: Barn Hunt rules apply to any activities held in the ring and surrounding property (includes car parking and grassy areas). Barn Hunt area is handicapped accessible.

Blinds: Blind will be 10x20 -- 5 competitors per blind for Instinct, Novice, Open and Senior, 4 for Master.

Leashes and collars: See the BHA Competitor Rulebook for specific information on what is allowed. Flexi-Leads are NOT allowed on event grounds.

Dog aggression: Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the event if justification is found by the judge and/or Event Committee. Entry fees will not be refunded.

Bitches in season: Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class. They must wear pants at all times (including on course) while not being pottied. They must be pottied in a designated area away from the other dogs. Entry fees for bitches that come into season will be refunded until the closing date of April 20, 2026, if you wish to withdraw. The trial secretary must be notified prior to or upon arrival. Failure to do so will result in a disqualification and dismissal from the event.

Videotaping and photography: Is allowed and encouraged!

Volunteers: Are appreciated and needed!

Sportsmanship: All competitors/handlers and spectators are expected to follow the rules of the BHA and demonstrate good sportsmanship. Please do not discuss hide placement or any details of a dog's performance that may provide information or clues to other handlers or may be overheard. Please be cognizant of teams competing in the ring and avoid loud or disruptive distractions.

Crating: Dogs must be leashed or crated when not actively working, and never tied out/left attached to anything other than a human. Crating space available outside on the grounds or in vehicles.

Payment and entry information: You can send entries via U.S. Mail or online through Dogshow.com and will be accepted in the order received. Entries will NOT be accepted without signatures and payment (cash or check or money order), entries are invalid without a signed Release Agreement Form. Owners are responsible for entry errors. Please write clearly and proof your entry. BHA will not make corrections once results are submitted. Incomplete forms, nonpayment, and returned checks are invalid entries. There is a \$30.00 fee for all returned checks. Entries accepted on a first come/first served basis. Refunds are ONLY allowed if requested before the closing date of April 20, 2026. No refunds for BIS.

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event a dog is absent, disqualified, sick, injured, excused, or barred from competition by action of the Event Committee

Champion Canine BH Club reserves the right to decline entries for cause and may remove any dog on account of dog or human aggression. No one shall have any recourse or claim against Champion Canine BH Club, or any agent thereof.

**Certification of Agreement upon Registration or Entry of Dog**

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered.
